DRIVING DIRECTIONS

WATERBURY OFFICE: 21 West Main Street, One Exchange Place, 3rd Floor, (203) 574-3777
(Free validation parking located in One Exchange Place building garage. Enter by way of Center Street)

Traveling East on I-84:

- Exit 22 (Baldwin Street).
- At 2nd light go left onto South Main Street.
- Proceed straight through the 1st intersection.
- Bear left at the next light (island intersection) onto Bank Street.
- Take 1st right onto Center Street.
- Turn right down ramp and proceed straight into parking garage. Look for sign on right.
- Use rear elevator.

Traveling North on Route 8:

- Exit 31 (I-84 East toward Hartford).
- Take Exit 22 (Baldwin Street).
- Proceed as above for I-84 East directions.

Traveling West on I-84:

- Exit 21 (Meadow/Bank Streets)
- Take a sharp right at the bottom of the ramp onto Field Street.
- Proceed up hill. Continue straight across intersection (Grand Street) on Leavenworth Street.
- At end turn right onto West Main Street.
- At 1st light turn right onto Bank Street.
- After 1st light turn right onto Center Street (about ¼ block).
- Turn right down ramp and proceed straight into parking garage. Look for sign on right.
- Use rear elevator.

Traveling South on Route 8:

- Exit 34 (Downtown/West Main Street).
- Take West Main Street towards downtown to the Waterbury Green.
- At the end of the Green take right onto Bank Street.
- After 1st light turn right onto Center Street (about ¼ block).
- Turn right down ramp and proceed straight into parking garage. Look for sign on right.
- Use rear elevator.

Traveling West on I-84:

- Exit 15 (Southbury). At end of Exit ramp take right.
- At 2nd light (Southbury Plaza) turn left onto Main Street South.
- At 2nd light take left onto Depot Hill Road.
- Take 1st left into parking lot, then a quick right to Building One, Suite 204.
- Enter from back of building.

Traveling East on I-84:

- Exit 15 (Southbury). At end of Exit ramp take a left.
- At 2nd light (Southbury Plaza) turn left onto Main Street South.
